














Overall Objective



- Being part of an economics, finances and accounting faculties;
- Knowledge of calculus, quantitative analysis and statistics ;
- Fresh graduates of a Bachelor degree or expected to be graduated within the academic year 2022-2023 (180 ECTS for European students, and the equivalent for non Europeans);
- English Language Requirements :
 - Being a native English Speakers
 - $\,\circ\,$ Or $\,$ Studying a university program in English
 - $\,\circ\,$ Or holding an English language qualification to the right level :
 - IELTS: 6.5,
 - TOEFL IBT : 79,
 - Cambridge English advanced certificate, grade B,
 - TOEIC : 900 (or equivalent).






- Assessment by a committee of faculty members of the School of Economics & Expertise France & the SCAC & PPFI team;
- Based on academic merit (the relevance of the degree/courses studied and overall grades), motivation and recommendations, curriculum vitae and language skills;
- Professional project must be in line with the objectives of the master's degree (especially link with public finance career path).

- Please fill in the application and e-mail it with the required documents to <u>claudine.belot@uca.fr</u>; in copy you should add <u>lyse.marques@expertisefrance.fr</u> to make sure you are applying at the same time to the Master's degree and to the Scholarship program.
- You should make sure you application include:
- \Box An updated CV
- □ Letter(s) of recommendation
- \Box A letter of motivation
- □ ID Copy
- □ Diplomas copies
- \Box Transcripts of records of each year of studies
- □ Copies of your language tests scores
- The application deadline for the Scholarship Program is : <u>31/01/2022</u> (different to the Master's degree deadline)
